In order to Gift Aid your donation you must tick the box below:

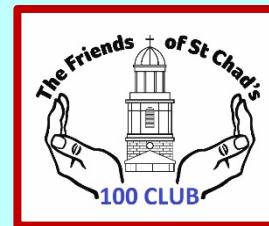

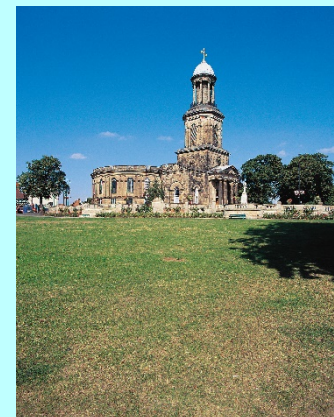

Club Rules & Regulations

1. The "membership year" will commence on 1st April and end on 31st March.
2. The payment of the required subscription shall bestow "membership" on the donor; payment of multiple subscriptions will not increase the "membership" status of any donor.
3. Members must be aged 16 or over. Proof of age may be required.
4. The subscription to the 100 Club shall be £12 per year per membership payable in advance; such sum may be increased following an approved Resolution by Trustees of The Friends of St Chad's Shrewsbury.
5. Members may have and are encouraged to have, multiple subscriptions.
6. Membership is not restricted to a Friend or a member of the Church and all are asked to encourage family and friends to join.
7. Members joining after the start of the normal 100 Club membership year will be charged a pro-rata amount.
8. The 100 Club shall not be limited to 100 members.
9. A member is eligible for inclusion in the draw for any month so long as the subscription for that month has been paid by the 1st of that month.
10. Each member is allocated a number on receipt of their subscription and this number will be used in the monthly draw. This number shall remain the member's for that year.
11. There shall be one prize draw per month save for [15] below.
12. The draws will be made on the first Sunday in each month in the Parish Hall in the presence of a Trustee of The Friends of St Chad's Shrewsbury. All members are welcome to be present to witness the draw.
13. The Prize Fund shall be 50% of the annual revenue to a maximum of 100 Members.
14. On the premise that the requirements of [12] are fulfilled, then the Monthly prizes will be as follows:
1st Prize - £20.00; 2nd prize - £15.00; 3rd prize - £10.00; 4th prize - £5.00
15. If membership is less than 100, then the prizes in [13] will be reduced by the same percentage that the membership falls short of 100.
16. In the event that membership exceeds 100, then a Super Prize Fund will be created into which will be put 50% of excess funds and a Super Draw will normally take place at Christmas & Easter (immediately after the normal monthly draw [13]) when the prizes will be allocated as:
Super Draw 1st Prize – 50%; Super Draw 2nd Prize – 25%;
Super Draw 3rd Prize – 15%; Super Draw 4th Prize – 10%
To be eligible for inclusion in the Super Draw, you must have been a member for the whole year i.e. April to March.
17. The remaining 50% of the subscriptions' revenue will be allocated to The Trustees of The Friends of St Chad's Shrewsbury General Fund Account.
18. The allocation of numbers and draw results will be posted in the Pew Sheet and on the noticeboard in the Church.
19. The 100 Club Administrator will make all reasonable efforts to pay prizes to the winners within one week of the draw.
20. The decision of the Trustees of The Friends of St Chad's Shrewsbury shall be final in all matters requiring adjudication.
21. Trustees of The Friends of St Chad's Shrewsbury shall also have the power to amend or revoke these rules at their absolute discretion with such reasonable notice to the 100 Club members as is necessary.
22. All correspondence concerning the 100 Club should be sent in the first instance to the Club Administrator and thereafter to the Secretary of Trustees of The Friends of St Chad's Shrewsbury.
